

RELEASE AND IDEMNITY AGREEMENT

WARNING: Under Kentucky Law, a farm animal activity, or a farm animal professional, or other person does not have a duty to eliminate all risks of injury of participation in farm animal activities. There are inherent risks of injury that you accept if you participate in farm animal activities.

I/we hereby indemnify and agree by this signing to release Brier Creek Farm, "Farm/Owner" and all associated persons from liability for any accident or injuries sustained by me, my employees, heirs, representatives, dependents or guest. It is understood that wherever the words "Farm/Owner" are used in this agreement it includes Brier Creek Farm LLC, Chad and Candra Wallgren, trainers, independent contractors and employees and any other individual related to the ownership or management of the horse facilities.

As an owner, student, spectator, employee, independent contractor or parent, I/we the undersigned, recognize that all equestrian related activities are extremely dangerous, that accidents involving horses are frequent, that the condition of the land is often hazardous, and that the ring footing is rarely perfect. The undersigned further agrees to wear protective riding equipment including, but not limited to, a hard hat where deemed appropriate by the Farm/Owner and to cooperate fully with the Owners in observing all rules and regulations for the premises that are promulgated by Stable/Owner. In light of this knowledge, I/we undertake full responsibility for all harm that comes to me/ourselves and my/our stock and all of my/our associates. With full knowledge, I/we release the hereinabove named Farm/Owner from any and all responsibility for accidents and injuries.

Signing this release implies that I/we have adequate medical and liability insurance/protection and that the Farm/Owner will assume no responsibility for horse or rider. Losses occasioned by the injury or death of rider, spectator or horse is agreed to be covered by the insurance of the undersigned and it is further agreed that the undersigned heirs, representatives, dependents or guest shall have no right or action against the Farm/Owner, employees, independent contractors, trainers or any of their insurance carriers.

If the person is under 18 years of age, signature of the parent or guardian indicates acceptance of responsibility by said parent or guardian and release of liability of the Farm/Owner and affiliated persons.

If damaged is caused by or to the undersigned's horse or horses (including, but not limited to, escape from enclosures), the undersigned takes full responsibility for damages to persons, property or other horses and agrees to indemnify Farm/Owner against liability for such damages.

The undersigned further agrees to indemnify Farm/Owner against any liability for physical loss or injury, or damage causing death, or making destruction necessary to horse or horses in Farm/Owner care.

It is understood and agreed that the Farm/Owner assumes no responsibility for personal property of the Horse/Owner's and said property is Stored on the premises alt the sole risk of the Horse/Owner.
